The District of Columbia (DC) Department of Motor Vehicles (DMV) has implemented the DC Insurance Verification System (DCIVS) in order to verify automobile liability insurance for vehicles registered in DC. DC's Compulsory/No-Fault Motor Vehicle Insurance Act <https://code.dccouncil.us/dc/council/code/titles/31/chapters/24/> requires you to maintain liability insurance on vehicles registered in DC.

This letter is to inform you that your DC vehicle registration for the vehicle listed above was **suspended**, effective as of 01/15/2006, because your insurance has not been sufficiently verified and/or you have not paid the applicable fine for any lapse in your insurance coverage.

D.C. Official Code §31-2403 provides for the suspension of your vehicle registration if you have not met the requirements. According to D.C. Official Code §31-2413.01(b)(2), a fine of \$150 will be assessed for a lapse in your insurance coverage from 1 to 30 days. For any lapse greater than 30 days, you will be assessed a fine of \$150 and \$7 a day for each additional day after day 30, up to a maximum amount of \$2,500. You are also required to pay a vehicle reinstatement fee of \$98 to reinstate your vehicle registration.

If the vehicle has **current liability insurance** or you **obtained liability insurance**, you must contact your insurance company or agent. Your insurance company or agent must electronically submit your insurance information to DCIVS using the www.DCIVS.org website and the reference number at the top of this letter.

If the vehicle has been **sold, registered out of state, or no longer required to have insurance**, you can go to the www.DCIVS.org website for instructions on how to respond to this letter. You may have to electronically submit required information.

You can obtain the total amount due and make a payment using the www.DCIVS.org website and the reference number at the top of this letter. You can also make a payment at any DMV Service Center.

The motor vehicle described above may not be operated until you have reinstated your vehicle registration. Operation of a vehicle with suspended registration is grounds for arrest, a fine of up to \$300 and 30 days in jail per D.C. Official Code 50-1501.04. If you no longer have insurance for the vehicle listed above, you must immediately surrender your tags. For options on surrendering your tags, visit <https://dmv.dc.gov/node/1118886>.
